1. IN CONNECTION WITH SHUTDOWN OF NATO LORAN-A,
WE UNDERSTAND THAT RESIDUAL VALUE OF NATO OWNED
FACILITIES AND EQUIPMENT AT COLOCATED NATO LORAN-A/
HOST NATION OPERATED LORAN-C STATIONS IS BEING
EVALUATED. SPECIFICALLY, WE HAVE LEARNED THAT
NATO REPRESENTATIVES HAVE BEEN EVALUATING RESIDUAL
VALUE OF FACILITIES AT LORAN-A/C STATION JAN MAYEN,
NORWAY. OTHER STATIONS THAT MAY BE AFFECTED ARE LOCATED
AT BO, NORWAY; AND SANDUR, ICELAND.

2. THE US REQUIRES LORAN-C OPERATIONS TO CONTINUE
AT THE ABOVE STATIONS WHEN THE NATO LORAN-A OPERATION

IS TERMINATED. THE FACILITIES AT THESE JOINT LORAN-
A/C STATIONS ARE CLOSELY INTEGRATED AND SUPPORT BOTH
THE LORAN-A AND LORAN-C OPERATIONS. BECAUSE THE
FACILITIES WILL NO LONGER BE REQUIRED FOR SUPPORTING
THE LORAN-A OPERATION AFTER 31 DECEMBER 1977, THE US
COAST GUARD, WHICH IS THE AGENCY RESPONSIBLE

FOR THE LORAN-C OPERATION, BELIEVES THAT ACTION REGARDING FUTURE OWNERSHIP OF THE NATO-OWNED FACILITIES COULD PRESENT NEEDLESS PROBLEMS THAT WOULD HAVE TO BE OVERCOME TO ENSURE UNINTERRUPTED LORAN-C SERVICE. THE WORST CASE ENVISIONED IS ONE WHEREIN THE US WOULD BE FORCED TO MAKE A CONSIDERABLE EXPENDITURE TO ACQUIRE TITLE TO NATO-OWNED EQUIPMENT CRITICAL TO LORAN-C OPERATIONS.

3. THE TYPES OF SUPPORT EQUIPMENT ESSENTIAL TO THE LORAN-C OPERATION INCLUDE GENERATORS, FUEL TANKS, UTILITY DISTRIBUTION SYSTEMS, AND SHARED BUILDINGS INCLUDING HOUSING.

4. THEREFORE, REQUEST ADVISE NATO PLANS FOR DISPOSING OF NATO OWNED PHYSICAL PLANT AND EQUIPMENT AT COLOCATED NATO LORAN-A/HOST NATION OPERATED LORAN-C STATIONS AT BO, NORWAY; JAN MAYEN, NORWAY; AND SANDUR, ICELAND. THIS INFORMATION IS REQUIRED IN ORDER TO ASSESS IMPACT OF LORAN-A CLOSURE ON CONTINUING UNINTERRUPTED

LORAN-C SERVICE. THE CONTINUATION OF UNINTERRUPTED LORAN-C SERVICE USING EXISTING FACILITIES WITHOUT INCURRING ADDITIONAL COST IS PRINCIPAL CONCERN OF THE US.
