1. PRES/COUNCIL BINAGHI HAS MADE TWO ADDITIONAL REQUESTS IN CONNECTION WITH COMMITTEE APPROVAL AND SECRETARIAT IMPLEMENTATION US PROPOSAL.
2. IMPORTANT THAT US MAKE CLEAR IT IS NOT REQUESTING REVIEW/ AMENDMENTS REGIONAL PLAN. SECRETARIAT CANNOT DO THIS -- ONLY MEMBER STATES. RESULTS OF REVIEW BY SECRETARIAT CAN COME TO COMMITTEE/COUNCIL FOR APPROPRIATE JOINT FINANCING DECISIONS AND MAY RESULT IN ONE OR MORE STATES MAKING PROPOSALS TO AMEND PLAN (JUST LIKE NAT SPG REPORTS LED TO DENMARK, ICELAND, AND CANADA PROPOSALS TO AMEND PLAN) WHICH ARE AUTOMATICALLY APPROVED BY PRES/COUNCIL IF NO STATE FORMALLY "OBJECTS." USREP SHARES BINAGHI CONCERN AND WILL PUT RECORD STRAIGHT AGAIN - NOVEMBER 26 MEETING.
3. BINAGHI ASKED USREP TO MAKE CLEAR TO CTE IN DIRECT OR INDIRECT STATEMENTS THAT THERE WILL BE FURTHER SUBSTANTIAL USAF PULL-OUTS IN 2-3 YEARS. RE WP/944 ATTACHMENT, LAST LINE TOP PARA, DEN UNCLASSIFIED
