RESENTMENT GROWING IN ICAO RE HOSTILE ATTITUDE MANY CANADIANS TOWARD DIPLOMATIC CORPS. QUESTION OF BAGGAGE SEARCH EXPECTED RESULT IN SOME HARASSMENT. END FYI.
