SUMMARY: SUBMISSION OF REPORT BY SPECIAL GOVERNMENT ENQUIRY GROUP ON "HELLEBUST" THESIS HAS SPARKED NEW SPATE OF PRO/CON ARTICLES IN NORWEGIAN PRESS. REPORT COMPLETELY EXONERATES GOVERNMENT DECISION-MAKING PROCESS. SENIOR MOD OFFICIALS ARE NOT CONCERNED BUT HOPE ISSUE WILL SOON FADE FROM PUBLIC ATTENTION. END SUMMARY

1. ALTHOUGH OMEGA AND LORAN C HAVE LONG BEEN VULNERABLE TO EMOTIONAL IF UNFACTUAL LEFTIST ATTACKS, AN UNHEALTHY FUROR WAS CREATED BY MASTER'S THESIS OF CAPTAIN HELLEBUST,WHO, AS NORWEGIAN INTELLIGENCE SERVICE OFFICER IN EARLY 1975, MISUSED HIS POSITION

PURSUIITS(REF C). THE THESIS ITSELF CHARGED THE MINISTRIES OF DEFENSE AND FOREIGN AFFAIRS WITH CIRCUMVENTING PROPER GOVERNMENT PROCEDURES IN AGREEING TO THE INSTALLATION OF THE SYSTEMS IN NORWAY AND THAT THESE SYSTEMS ARE OPERATED IN US(FOR POLARIS TARGETING)RATHER THAN NORWEGIAN INTEREST.

2. A FORMAL ENQUIRY GROUP WAS ESTABLISHED TO INVESTIGATE HELLEBUSTS CHARGES IN MARCH 1975(SEE REF B) THE GROUP HAS NOW CONCLUDED ITS INVESTIGATIONS AND A REPORT WAS SUBMITTED TO THE GOVERNMENT ON 23 DEC. THE REPORT CONCLUDES THAT THERE HAS BEEN NO DECEPTION INVOLVED IN NORWAY'S ACQUISITION OF OMEGA AND LORAN C SYSTEMS NOR ANY ATTEMPTS TO COVER UP THE REAL PURPOSE OF THE SYSTEMS. THE SUBMISSION OF THE REPORT HAS BROUGHT PAST CRITICS OF OMEGA/LORAN C OUT OF THE WOODWORK TO BLAST THE CONCLUSIONS OF THE ENQUIRY GROUP AS A WHITEWASH. EDITORIALS,CHARGES AND COUNTERCHARGES HAVE BEEN APPEARING FREQUENTLY IN THE PRESS WITH A MAJOR DEFENSE OF THE INQUIRY GROUP'S CONCLUSIONS AND THE NORWEGIAN GOVERNMENT POSITION PUBLISHED AS UNATTRIBUTED ARTICLE IN OSLO'S LARGEST DAILY "AFTENPOSTEN". HELLEBUST HIMSELF HAS THREATENED TO "GO PUBLIC" WITH SOME OF HIS MORE SENSITIVE ALLEGATIONS NOW THAT THE GOVERNMENT REPORT HAS BEEN RELEASED.

3. SECRETARY GENERAL OF THE MINISTRY OF DEFENSE CASPER STEPHANSEN ADVISED EMBASSY THAT SENIOR LEVEL OF NORWEGIAN GOVERNMENT IS NOT CONCERNED AT THIS POINT AND OFFICIALS ARE WELL EQUIPPED TO REBUT HELLEBUST'S ACCUSATIONS WITH HARD FACTS. REPORT OF INQUIRY GROUP NOW BEING CIRCULATED FOR COMMENT TO THOSE GOVERNMENT DEPARTMENTS INVOLVED ALTHOUGH NO FURTHER GOVERNMENT ACTION IS ANTICIPATED. STEPHANSEN EXPECTS AND INDEED HOPES THAT THE ISSUE WILL SOON SUBSIDE AND EBB FROM THE PUBLIC DOMAIN.
