1. Substantative changes to the organization of the Fourteenth Coast Guard District were authorized by reference (a), specifically:

- a. Disestablishment of U. S. Coast Guard Section, Philippines.
- b. Establishment of Senior Coast Guard Officer, Philippines.
- c. Establishment of Loran A Technical Assistance Detail, Manila.
- d. Designation of the Commanding Officer, Merchant Marine Detail, Manila as Senior Coast Guard Officer, Philippines.

2. Changes to OPFAC (CG-244) required by these actions, together with suggested OPFAC numbers, are:

- a. Delete CG Section, Philippines
- b. Add Senior Coast Guard Officer, Philippines

- c. Add CG Loran A Technical Assistance Detail

The OPFAC Number proposed for "Loran A Technical Assistance Detail" is the same as that currently assigned to "CG Section, Philippines", their mission being a continuation of the principal duties of PHILSEC.

Subj: Operating Plan Change Order; request for issuance of Both "Loran A Technical Assistance Detail" and "CG Merchant Marine Detail, Manila" are units under "Senior Coast Guard Officer, Philippines".

3. Changes to the SDL (CG-131) required by these actions, including suggested placement of the listing for the re-titled organizational elements, are as follows:

These changes are submitted as enclosures to this letter to insure that references to sections of the SDL are correct.

4. With this command structure the Commanding Officer, Merchant Marine Detail, Manila, will also be the Senior Coast Guard Officer, Philippines (SCGOP). The present Deputy Section Commander (LCDR) billet should be designated Commanding Officer of the Technical Assistance Detail, to serve also as SCGOP (Acting) in the absence of the officer specifically assigned as such.

5. Pursuant to paragraph 2 of reference (a), the commander billet presently authorized for the Section Commander should be deleted. The remainder of the billets now assigned to Philippine Section Office should be retained for the Technical Assistance Detail.

6. It is requested that an OPCO be issued to effect the foregoing changes, with an effective date of 1 February 1973.
