1. COAST GUARD HAS ADVISED US THAT U.S. REQUIREMENT FOR LORAN-A STATIONS IN THE PHILIPPINES DOES NOT EXTEND BEYOND 31 DECEMBER 1977. INTENTION IS TO ALLOW US/GOP AGREEMENT COVERING OPERATION OF STATIONS TO EXPIRE ON THAT DATE AND NOT TO RENEW IT. UNDER THE AGREEMENT, US HAS PROVIDED TO GOP OPERATING EXPENSES IN AMOUNT OF 25,000 DOLLARS PER YEAR, SPARE PARTS SUPPORT AND HAS MAINTAINED A TECHNICAL ASSISTANCE TEAM IN MANILA. IN RETURN, GOP HAS OPERATED

2. EMBASSY IS REQUESTED TO ADVISE GOP OF OUR INTENTION TO LET AGREEMENT EXPIRE AND IN SO DOING END OPERATING PAYMENT, SPARE PARTS SUPPORT AND WITHDRAW TECHNICAL ASSISTANCE DETAIL.

3. IF GOP DESIRES TO CONTINUE LORAN-A OPERATIONS AND REQUESTS TECHNICAL AND SPARE PARTS SUPPORT, COAST GUARD WILL ENTERTAIN SUCH REQUESTS ON REIMBURSABLE BASIS. IT SHOULD BE MADE CLEAR THAT SUCH SUPPORT WOULD IN ALL PROBABILITY COME FROM SOURCES OUTSIDE THE PHILIPPINES THUS INCREASING CURRENT TIME AND COST FACTORS. CHRISTOPHER
