
1. At 1200 this date Ensign William F. Tighe, Jr., USCG, relieved Chief Radio Electrician L. J. DeGraw, USCG of duties as Commanding Officer, CG Loran Transmitting Station, Ichi Banare, Okinawa in compliance with orders contained in Ind-9 of reference (b).
2. Article 1017, RPS 4B, was complied with, and the report forwarded direct to Headquarters.
3. Article 905, CG Regulations, was complied with. The Record of Public Property was found to be complete and in good condition. *K/S*
4. One International 6x6 and one Trackson Swing Crane were found to be in an inoperative condition. One main generator was found to be in a badly worn condition and will not carry a load for any length of time. The buildings were found to be in fair condition, needing work on the galley roof of the Commanding Officer's quarters and the after portion of the main galley roof as well as the renewal of some flooring and bracing. Several minor items of equipment were found to be in poor or inoperative condition and are the subject of an inventory report of the Record of Public Property submitted to the Commander, 14th Coast Guard District.
5. A joint commissary inventory was taken and the mess found to be in good condition. A commissary report for the period 1 September, 1948 to 1200, 27 September, 1948 was completed and forwarded to the Commander 14th Coast Guard District. Relief as commissary officer was tendered and accepted. *AS*
6. Other than as noted in paragraph (4), the station was found to be in good condition and relief was accepted.
