1. Information

a. This Operations Order is derived from Commandant (OFU) letter to Com14CGD dated 3 February, 1953.

b. The KUKUI has been assigned by the Commandant to implement the construction phase of Fourteenth Coast Guard District loran installation program - 1953, which provides for the transportation of men and materials and the construction of three (3) loran transmitting stations to be established at:

- Batan Island, R. P. (ELMO 7)
- Catanduanes Island (Panay Island), R. P. (ELMO 8)
- Anguar Island, Palau Islands (ELMO 9)

For the sake of brevity, the aforesaid stations will be subsequently referred to herein as ELMO 7, ELMO 8, and ELMO 9, respectively.

c. Commander, 12th Coast Guard District has been requested by the Commandant to assume operational cognizance of the staging and unloading phases of ELMO 7 and ELMO 8 on board KUKUI at Coast Guard Supply Center, Alameda, and to arrange transportation of ELMO 9 to Guam, M. I.

d. The Commandant has obtained diplomatic clearance for the KUKUI to enter, base, and operate in territorial waters of the locations cited in paragraph (b) above.

e. Commander, 14th Coast Guard District will coordinate transportation of contractor personnel and equipment necessary for construction of ELMO 7, ELMO 8 and ELMO 9 in accordance with movements of KUKUI.

2. This force will provide such necessary services as may be required to transport and establish ELMO 7, ELMO 8 and ELMO 9 in order to insure their future operation as loran transmitting stations.
3. a. KUKUI
 - (1) When directed by Commander, 12th Coast Guard District, depart Alameda, California with your command and proceed in accordance with Movement Plan, Annex A.
 - (2) Advise Commander, 14th Coast Guard District and Commandant (O) of delays or diversions of more than 48 hours duration from Movement Plan, Annex A.
 - (3) Provide for loading, stowage, and transportation from Alameda, California of mobile equipment, personnel, and materials necessary to the establishment of ELMO 7 and ELMO 8 at their respective designated sites.
 - (4) Provide for loading, stowage, and transportation from Guam, M. I. of mobile equipment, personnel, and materials necessary to the establishment of ELMO 9 at its designated site.
 - (5) Offload and deliver to shore points above the high water mark, as near as practicable to their designated sites, mobile equipment, personnel and materials aforesaid.
 - (6) Establish and support the mobile loran stations until they are self-sustaining, at which time release custody of mobile components, spare parts, outfitting equipment, fuel, and stores to the respective Commanding Officers.
 - (7) Assist in providing transportation for contractor's equipment and personnel as may be directed by Commander, 14th Coast Guard District.
 - (8) Submit a special report to Commandant (OAN) via Commander, 14th Coast Guard District upon the establishment of each station; details concerning transfer of custody thereof; damage to equipment and construction materials; and responsibility for such damage.
 - (9) Upon completion of above mission submit a narrative report to the Commandant (O) via Commander, 14th Coast Guard District containing opinions and views relative to the employment of the KUKUI in connection with the subject program; plans relative thereto; and recommendations concerning future operations of the same type.

- (3) Assume operational control and furnish continued logistics support for ELMO 9 upon establishment at its designated site.
