1. The following facilities are allocated to you as of 16 February 1946. Allocation includes contents and equipment contained therein which are retained by you.

a. Area, including one (1) one-story building, known as O-Shima Plantation Park, O-Shima, Sagami-nada, as shown on attached sketch. Location approximately 139°27' E, 34° 40' N. Requested by your unit for Loran station, a permanent installation.

2. This Notice of Allocation cancels and supersedes Notice of Allocation Z-865, dated 7 October 1945. Area allocated thereunder is included herein.

3. Request receipt of these facilities be furnished this headquarters by 2 March 1946.

4. When the facilities listed herein are vacated, request report of same be made to this headquarters.

1. Enclosed are original and copies of USASCOM-C Allocation Notice number Y-615, for land occupied by this unit. This cancels and supercedes Allocation Z-865 and has been remade because of incomplete files at USASCOM-C.

2. This allocation differs from the original land survey in only one particular. The boundary running 004 degrees 03 minutes True was extended to 200 (two hundred) feet from the original 150 (one hundred fifty) feet, thus taking in an additional area at the northern end of the station. It is requested that charts of this unit's land be corrected accordingly.
