WE HAVE BEEN FOLLOWING TRAFFIC ON CONTINGENCY PLANNING FOR POSSIBLE REMOVAL SEA LORAN C ELEMENTS FROM CON SON ISLAND WITH GREAT INTEREST. RECOGNIZING THAT CURRENT USEFULNESS OF STATION SHOULD BE DECIDED UPON BY COMUSSAG, WE SOULD LIKE TO POINT OUT THAT CON SON ISLAND IS NOT IMMEDIATELY THREATENED. IF SECURITY SHOULD GENERALLY DETERIORATE, CON SON IS SUFFICIENTLY REMOTE FROM MAINLAND TO ALLOW TIME FOR ORDERLY REMOVAL OF HIGH VALUE EQUIPMENT AND PERSONNEL.
