## PETTY OFFICER JAMES T. LIGON UNITED STATES COAST GUARD

James T. Ligon was born and raised in Greenville, SC and joined the Coast Guard in January 1980. After basic training at TRACEN Cape May, NJ, he was stationed aboard USCG Cutter CONIFER, Atlantic Beach, NC. ET1 Ligon advanced to 3rd Class Boatswains Mate and was transferred to smallboat station Sandy Hook, NJ in 1983 where he received his first Coast Guard Achievement Medal. In 1985 he crossed over to the electronics field and graduated from Electronics Technician Class "A" school, Governor's Island NY. ET1 Ligon was then assigned to Air Station Elizabeth City, NC. His first LORAN experience was at Lorsta Hokkiado Japan in 1989. In 1990 ET1 Ligon was assigned to Lorsta Carolina Beach NC. In 1994, he crossed the street for a tour on board USCGC DILIGENCE, homeported in downtown Wilmington, NC where he received his second Coast Guard Achievement Medal. In 1994, he again returned to serve at Lorsta Carolina Beach as the Executive Petty Officer and presently as the interim Officer-In-Charge.

## CHIEF PETTY OFFICER JOHN G. SAULS UNITED STATES COAST GUARD

John G. Sauls was born in Great Falls, MT and raised in Lake City, FL. In 1982 he joined the Coast Guard and attended basic

training at TRACEN Cape May, NJ.

After completing basic training, ETC Sauls was assigned to the USCGC Dependable (WMEC-626) in Panama City, FL. In February 1984 he reported to Governors Island, NY for Electronics Technician School. Upon completion he served at LORMONSTA Spruce Cape, in Kodiak Island, AK. Loran Station Malone, FL was his next assignment. After completion of an associates degree and employment by the U.S. Postal Service, he returned to the Coast Guard in 1989 and served aboard the USCGC SENECA (WMEC-906) in Boston, MA.
