Ref: (a) Forest Service ltr of March 14, 1974

1. Commence the removal of refuse described in reference (a) and transport to a sanitary disposal facility as soon as weather permits.
2. Explore the possibility of hiring a local contractor to load and haul the material to the designated disposal facility.
3. It must be stressed that removal of this debris shall be accomplished prior to 30 June 1974.
4. Letter reports of amount of refuse removed and remaining at 30 day intervals commencing 1 May 74.
5. Coordinate inspection of the sites upon completion of this project with Mr. Dick Powers, Resource Management Assistant.

1. The subject refuse is comprised of two major locations, one to the North and one to the South of our station. Both locations and surrounding areas have been inspected by this command subsequent to the recent thawing.
2. Due to the vast and burdensome size of much of the debris, especially accumulated at the North site, this unit will require local assistance.
3. This command has recently discussed the project with Mr. POWERS and Mr. Edward DIERICK, Forman, Alaska State Highway Department. During the week of 6 May a meeting with the above mentioned gentleman has been planned, to discuss details and assure that the outcome will be mutually agreeable by all parties involved.
4. A major portion of the North site does not appear to be Coast Guard originated. This topic will be discussed at the meeting. The services of Mr. DIERICK will be utilized in removal operations and costs incident will be reflected on this units monthly State Highway Dept. Bill of Collection. This unit does plan to participate in the actual transfer operation as much as our capabilities safely allow.
5. Pictures of the sites have been taken and when printed, by this unit's photo lab,, will be forwarded to District (o) along with results of the above mentioned meeting.

1. The subject refuse, located at both the North and South sites, was transported to an acceptable disposal facility during the period 9-10 May 1974. In addition, all surrounding grounds were policed and found to be free of refuse.
2. All parties involved, Mr. Edward Dierick and Mr. Dick Powers, concurred with an initial plan discussed at a seven May meeting and cooperated to the fullest extent in affecting the actual transfer operation.
3. Upon completion of the refuse transfer, the subject sites were inspected with Mr. Powers on 13 May and the results met with satisfactory approval.
4. Enclosed herein are pictures portraying the refuse sites before and after the removal operation. This unit will endeavor to impose strict measures to curb improper refuse disposal in the future.
